

PRIVACY STATEMENT

Policy

The Nest Community Ltd is committed to its privacy statement that safeguards the privacy of members, clients and the public and complies with the Privacy Act 1998.

Definition

A privacy statement is a document that declares the intentions of the organisation in relation to:

Procedure

Data collection

The Nest Community collects personal information such as name, phone number and address for issuing tax-deductible receipts, to accept registrations for workshops, volunteering opportunities and programs. The information is collected in a fair, legal, and transparent way.

Data storage

Data is stored in various platforms that maintain high security and ensure confidentiality of personal information.

- Personnel files are stored in a secure location within the premises.
- No credit card details are kept on file.

Data use

The organisation only uses the personal information collected for the purposes for which it was required, or other purposes that are agreed to by the organisation and the individual. We do not share your data with third parties.

Data disclosure

The Nest Community Ltd undertakes to disclose your data only under the following circumstances:

- where required or permitted to do so by law; and
- with your consent.

- without cost

- 3. to assist in investigating your complaints, feedback, and inquiries
- 4. for other purposes which are reasonably necessary in connection with our normal functions and activities.

We may disclose your personal information to the following kinds of entities: our contractors, consultants, advisers, associates and related entities; the owners or operators of any app or platform that you have subscribed for through us; entities that provide services to us; any industry body, tribunal, court or otherwise in connection with any complaint made by you about us; and other entities with your consent or as permitted or required by law.

How you may access or seek correction of your personal information or make a complaint
